All of whom shall henceforth be individually and collectively referred to as, "The Trustees" (which expression shall include their successors and new appointees in office) on the OTHER PART.

WHEREAS The Author intends to establish a Trust for the purpose of establishing and setting up educational institutions of world repute and international standards presently at Bangalore and than at other places the world over in course of time and for which purpose has created this Trust.

2. The official address of the trust shall, until subsequently changed by the Trustees be at 29, I Main Road, Chamarajpet, Bangalore 560018. The Trustees may by resolution shift the office of the trust to such other places as they may deem convenient.
3. The Author has this day transferred and given a sum of Rs.10, 000/- (Rs. Ten Thousand Only) to The Trustees, the receipt of which sum the Trustees hereby acknowledge, towards corpus of the trust, to be held in trust along with any accrued or other income or receipt so as to form part of the Trust Property, and to be utilized for the purpose of achieving/ fulfilling the objects of the trust.
4. The Office Bearers of the Trust shall consist of the President, Secretary and Treasurer of the trust. No non-trustee shall be appointed as an office bearer. The Author of the Trust shall be the first President of the Trust. The first Secretary and Treasurer shall be such of the Trustees so appointed by the President as per his discretion. Subsequently appointment shall be by means of duly passed resolutions at trust meetings.





5. The Trustees shall have power to appoint both permanent and fixed term trustees. Appointment of a person as either a permanent or a fixed Term Trustee shall be by resolution passed by a simple majority at a duly conveyed trust meeting. The total number of permanent trustees shall not at any one point of time exceed six. Similarly the total number of Fixed Term Trustees shall not exceed five at any one point of time. All Permanent Trustees present and future shall hold office for life while each of the Fixed Term Trustees shall hold office for the nominated period commencing from the date of his/ her appointment. The office of Fixed Term Trustee shall be deemed to have been vacated upon the completion of the period they are nominated for and no further acts are necessary in this regard. The Trustees may by resolution prescribe any sum to be paid by way of gift or donation to the trust as a pre-requisite for appointment of a new Trustee.

6. The aims and objects of the trust shall be;


- To establish, maintain, run and manage educational institutions, from nursery schools to post graduate, doctoral and research studies,
- To afford all such educational facilities to the public through the educational institutions so set up. The facilities can be commercial, technical, physical or such as may be decided by the trustees from time to time,



7. The Trustees shall have power to do all or any of the following acts, for and on behalf of the trust in fulfillment of its aims and objects;
- a. To manage the activities of the trust in keeping with its aims and objectives,
  - b. To accept gifts, contributions or donations either in cash or in kind in relation to fulfillment of the aims and objects of the trust,
  - c. To accumulate the income of the Trust and amalgamate the same with the corpus of the Trust and also to invest the surplus or other Trust Funds in whatever form and mode as may be deemed fit, but in accordance with the provisions of the Income Tax Act,
  - d. To acquire, purchase or sell, lease or sub-lease, at their discretion, and immovable or movable property as the case may be, in the course of management and administration of the trust. However, sale of immovable property shall be made only by a resolution duly passed by a three-fourth majority of the Permanent Trustees in a duly conveyed trust meeting,

- e. To mortgage or pledge the trust property for raising loans,
- f. To prescribe rules and/ or by- laws in relation to all administrative matters of the trust, fulfillment of the aims and objects of the trust and also the conduct of trust meetings, its affairs, and functions such as appointment/ termination of staff and servants etc.
8. The functions and duties of the Trustees shall be as may be prescribed/ assigned to them by the President from time to time, in additional to those prescribed under the Indian Trust Act, 1882. The President has sole discretion to form sub-committees of Trustees for any specific or general purpose.
9. The Trust Funds shall consist of the amount of Rs.10,000/- settled on the trustees this day by the Author, gifts, donations, contributions received, grants, aids, subsidies, loans, endowments, deposits of all kinds, and income from investments, movable and immovable properties.
10. The Trust Property shall include the Trust Funds, and all movable and immovable property belonging to the Trust. It is stated that as on this day, the trust does not have any immovable property.
11. All decisions of the Trustees shall be effected by way of duly passed resolutions at duly conveyed trust meetings. However, were a three-fourth majority is

12. All Trustees shall be given three clear days prior written notice of meetings of the Trustees indicating the date, time, and venue. In case of emergency meetings it is sufficient if all the trustees concerned are duly intimated. At least four trust meetings shall be held each accounting year.
13. The Trustees shall cause regular accounts to be maintained and such accounts shall be audited by a practicing chartered accountant every year. The accounting year for the Trust shall be from 1<sup>st</sup> April to the 31<sup>st</sup> March of the subsequent year.
14. The Trustees shall (by a resolution duly passed by three-fourth majority of all trustees) be entitled to amend, alter, add to and/ or rescind any of the clause/s of this Trust Deed (except object clause 6 dealing with the aims and objects of the trust) to remove any difficulty that may arise for the proper conduct of the trust activities, and in order to bring about any improvement in achieving the objectives of the trust.
15. In the event of dissolution or winding up of the Trust, which shall be by a three-fourth majority of the total number of permanent trustees holding office as on date of resolution, the assets remaining on the dissolution shall be transferred to another trust whose objects are similar. In no event shall the assets so remaining be distributed amongst the Trustees.
